GROOVY BOURBON RAFFLE TERMS AND CONDITIONS

Cabarrus Meals on Wheels, Inc a nonprofit corporation recognized by the IRS as tax-exempt under Section 501(c)(3) of the Internal Revenue Code, is conducting this raffle pursuant to North Carolina law to raise funds for ongoing charitable purposes. The Official Rules of the raffle are set forth below.

PARTICIPATION CONSTITUTES ACCEPTANCE OF RULES AND DECISIONS, CONSENT TO USE AND RELEASE OF CLAIMS. By entering this raffle, each participant warrants that he or she has read and agrees to abide by all raffle rules ("Official Rules") and that he or she is not prohibited from participating in the raffle. Participation in this raffle constitutes participant's full and unconditional acceptance of these Official Rules and the decisions of the Foundation and its subsidiaries, affiliates, employees and agents, which are final, binding and non-negotiable in all respects. Each participant agrees to release, discharge, indemnify and hold harmless Cabarrus Meals on Wheels, Inc and each of its respective parents, subsidiaries, affiliates, related entities, employees, officers, directors, members, agents, representatives, advertising and promotion agencies and prize suppliers from any liability arising from or related to the raffle and/or the receipt or use of any prize awarded in connection with the raffle, including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy.

1. Sponsor. Cabarrus Meals on Wheels, Inc, is the sponsor of The GROOVY Bourbon Raffle 2024 (referred to as "Raffle"). Cabarrus Meals on Wheels, Inc, is a 501(c)(3) non-profit organization. The purpose of the Raffle is to raise funds for Cabarrus Meals on Wheels, Inc.

2. Raffle Overview. Raffle tickets are eligible for purchase beginning on July 1, 2024. Raffle tickets will no longer be available for purchase after 8:00 PM EST on October 19, 2024, or upon ticket sell-out, whichever occurs first. Three winners will be drawn and announced on October 19, during the 1974 Groovy Gala/ Party

3. Eligibility. This raffle and the ability to purchase a chance (referred to as “Ticket”) is open to legal permanent residents of the U.S., 21 years of age and older. Proof of age and identity must be furnished upon request. VOID WHERE PROHIBITED BY LAW. ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS APPLY. CAUTION: any attempt by a participant to undermine the legitimate operation of the raffle may be a violation of criminal and civil laws and, should such an attempt be made, the organization reserves the right to fully prosecute and seek damages from any such participant of the law.

4. Rules. By purchasing a Ticket, each Ticket Holder accepts and agrees to be bound by all the rules, limitations, conditions, and restrictions set forth herein (referred to as the “Rules”), as well as all applicable local, state, and federal laws and regulations. Cabarrus Meals on Wheels, Inc has sole discretion in all matters concerning the Raffle and its interpretation and application of the Rules shall be final. Please contact Cabarrus Meals on Wheels, Inc if you have questions regarding the Rules or the Raffle. The Raffle is void where prohibited by law.

5. Releases. By purchasing a Ticket, each Ticket Holder releases Cabarrus Meals on Wheels, Inc and the nonprofit’s Directors, Officers, Employees, and Agents, from any and all liability with respect to the raffle, including, but not limited to, the selection process and the interpretation and application of the Rules, and from any and all liability for injuries, losses, or damages of any kind caused by winning Prize or resulting from acceptance, possession, use, or misuse of winning Prize, and each Ticket Holder agrees to indemnify and hold Cabarrus Meals on Wheels, Inc harmless from any and all losses, damages, rights, claims, and actions of any kind arising in connection with the winner’s acceptance or use of winning Prize. Ticket Holder agrees to the use of their name, likeness, and any statements made by them regarding the Prize may be disclosed to, and used by, the news media, and/or marketing agency and may otherwise be used by Cabarrus Meals on Wheels, Inc for advertising or publicity purposes without compensation, and in any published articles in area newspapers and other media.

6. Tickets. The cost to purchase a Ticket for the Raffle is \$100 (U.S. Funds only). Any eligible person may purchase more than one Ticket. Odds of winning depend on the number of valid Tickets sold. Tickets will no longer be available for purchase after 8:00 PM EST on October 19, 2024. Any unsold tickets become the property of Cabarrus Meals on Wheels, Inc and will not be included in the drawing. Ticket Holders will receive an email which confirms receipt of payment. The IRS has taken the position that amounts paid for chances in raffles, lotteries, or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. A Ticket is not valid and shall not be entered in the Raffle until full and satisfactory payment for such Ticket is received by Cabarrus Meals on Wheels, Inc. Tickets are non-transferable once purchased.

7. Failure of Payment. If a Ticket Holder's payment by credit card is declined or payment is dishonored by the bank for any reason, such Ticket Holder's Ticket shall be invalid and will not be entered in the drawing, unless full and satisfactory payment is made by 8:00 PM EST on October 19, 2024. Cabarrus Meals on Wheels, Inc will endeavor to notify the invalidated Ticket Holder by phone at the number or email provided on the ticket purchasing website; however, any failure to do so shall not cause the Ticket to become valid, cause the Ticket to be entered in the Raffle, or give rise to any claim or cause of action on behalf of the invalidated Ticket Holder.

8. Multiple-Party Tickets. If more than one name is listed on a Ticket, the first name listed shall be deemed to be the Ticket Holder. Delivery or payment of the Prize shall be made to the Ticket Holder. It is the responsibility of the Ticket Holder to allocate any such Prize among the participants in a multiple-party Ticket and Cabarrus Meals on Wheels, Inc, its Directors, Officers, Employees, and Agents, shall have no liability for any failure to do so.

9. Raffle Drawing. The Raffle Drawing shall take place via a live event on October 19, 2024, during the 1974 Groovy Gala/Party held at 601 Milestone Venue, 601 Warren C. Coleman Blvd, Concord, NC 28025 In order to be eligible for the Raffle Drawing, a Ticket Holder must have purchased their Ticket before 8:00 PM EST on October 19, 2024. The winning Tickets will be randomly chosen by hand (not using any auto-

generators), and the winners of the raffle will be notified via contact information provided. If the Raffle is not held, all money will be returned to the Ticket Holders. There is no substitution of Prize. Ticket Holders do not need to be present to win.

The Raffle will produce three (1) chances to win a Prize. Prizes are detailed below. All raffle tickets will be combined into one pool or pile, the drawing will pull, one (1) winning Ticket. The first selected ticket will be the set of bourbon.

10. Claiming a Prize. Winning Ticket Holders will be notified by phone and/ or email and/ or mail at the number or email address or address provided when the Ticket was purchased. Cabarrus Meals on Wheels, Inc shall notify the winner within seven days of the drawing. The winner and Cabarrus Meals on Wheels, Inc will negotiate a date for the physical claiming of the Prize because it cannot be shipped. 11. Obligations of Winning Ticket Holders. Except as otherwise provided herein, the Ticket Holder who wins the Prize is responsible for all costs associated with Prize, including, but not limited to, any local, state, and federal taxes that may be applicable. The winning Prize will be made available for in-person pick-up by the winner or designated representative at the Cabarrus Meals on Wheels, Inc office located at [342 Penny Lane Concord, NC 28025](https://www.google.com/maps/place/342+Penny+Lane,+Concord,+NC+28025). Signature and Ticket Holder verification will be required upon pick-up. When Cabarrus Meals on Wheels, Inc notifies the winning Ticket Holder, arrangements for the pickup will be discussed and confirmed.
